

## All Systems Annual Overweight Permit Request

This version of the All Systems Permit is for weight only. On May 23, 2022, Governor Reynolds signed SF2376 into law which created this new permit, effective January 1, 2023. State roads were required to be valid for the permit on January 1, 2023. Counties have until July 1, 2025, to determine which routes in their jurisdiction can be used with the new permit. Currently, there is no date required for the cities to indicate participation. The permit costs \$500 per truck. 75% of the revenues are shared among participating counties, and the remaining 25% is distributed according to the standard Road Use Tax distribution.

The All Systems Annual Overweight Permit is an annual permit that allows for unlimited trips on all State, and US routes (not valid for Interstate travel), as well as approved city/county roads for loads which are categorized under the following maximum dimensions:

### Maximum Dimensions for Legal Loads:

- Length: Legal
- Width: 8'6"
- Height: 13'6"
- Gross Weight for 5 axles: 89,600 pounds maximum based on axle spacing
- Gross Weight for 6 axles: 100,800 pounds maximum based on axle spacing
- Gross Weight for 7 axles: 107,520 pounds maximum based on axle spacing
- Maximum Axle Weight: 20,000 pounds per axle

### Farm-to-Market Routes

All paved Farm-to-Market (FM) routes must allow travel of these overweight vehicles under this permit as of July 1, 2025, unless a written exception is approved by the Iowa DOT. FM routes are county jurisdiction only, but cities may have FM routes through them. Cities under 2,500 population need to work with the counties on these routes.

### Designated Truck Routes

All designated truck routes must allow travel of these overweight vehicles under this permit as of July 1, 2025. For the purposes of this permit, truck routes are either: (1) those routes designated in the city's Code of Ordinances (Chapter 66) as a truck route or (2) those routes physically signed as truck routes. After July 1, 2025, all truck routes shall allow travel by these permit vehicles unless a written justification is submitted and approved by the Iowa DOT.

Carriers are required to check state and county 511 maps when traveling on county roads or city streets for bridge embargo, detour, road embargo and vertical clearance information.

**Actions Required:**

Please return the following form and map(s) for your city along with your municipal road update.

1. Truck Routes: Provide a map indicating your city's truck route
  - Truck routes are those routes designated in the city's Code of Ordinances (Chapter 66) and/or are those routes physically signed as truck routes.
2. Route Restrictions: Complete the following form and/or provide a map indicating your city route restrictions
  - If you would like for your city to be listed as "All Restricted" or "No Restrictions" please check the appropriate box on the following page and sign and return the form to Joshua Slotter ([Joshua.Slotter@iowadot.us](mailto:Joshua.Slotter@iowadot.us)) in the Research & Analytics Bureau.
  - If you would like to list where any route/segment restrictions are located within your city, please make these notations on a separate PDF map of your city located with the city updates at <https://iowadot.gov/analytics/analytics-home> and provide a corresponding list detailing these locations; such as: "59<sup>th</sup> Street between ECL of Vinton and 25<sup>th</sup> Avenue". This will help us to both assist the public and place the restrictions in a spatially correct location within the database.

Bridge restriction data will be pulled from the All-Systems Permit field in SIIMS (Structural Inventory and Inspection Management System). These restriction statuses will automatically be displayed on the restriction maps. Local public agencies need to populate the All-Systems Permit field in SIIMS.

Temporary route and bridge restrictions can be communicated to the Iowa DOT to be shown on the state 511 website.
