The Non-Federal-aid Project Development Guide (The Non-Federal-aid Guide) January 8, 2021	The Non-Federal-aid Guide is a new document. The Non-Federal-aid Guide provides a concise summary of information and instructions for local public agency (LPA) staff and consultants involved in the planning, development and construction of LPA non-federal-aid transportation projects. Where appropriate, the Non-Federal-aid Guide references the I.M.s and other documents for more detailed information and instructions.

Dates and Information January 8, 2021	 Revised the chart from Attachment A and B to just be one chart, in the I.M. (not an attachment). Attachments A and B have been deleted. Revised the submittal dates to show a Concept Statement for a major project being due a year before letting, and a minor concept due at the same time as preliminary plans (6 months prior to letting). Revised the chart so each submittal date is either the first Tuesday or the third Tuesday of each month. The headings are now in chronological order of the submittals, and listed as headings instead of a numbered list. Clarifying that the PDC is due at the same time as the Final Plans. Additional documents are also due at this time, and not at the time in which the Administering Bureau needs to turn in submittals to the Contracts and Specifications Bureau.
