- Real-world Training Pilot counties were able to issue PWD stickers to test the strength of the training and platform MVD developed.

Business Requirements

Code of Iowa/Administrative Rules/ARTS Functions

- Requires documentation codified in Iowa Code Chapter 321L.
- Definition of a resident in Code Section 321.1A is applicable to Code Chapter 321L.
- There are multiple hard stops in this process.
 - Issuance staff must apply the process.
 - Enhancements for MVD360 for PWD stickers have been submitted. This includes pairing the PWD sticker with a license plate.
- Stickers are valid for as long as the registration on the vehicle remains current.
 - 5-year renewal for a standard PWD placard helps to establish if the sticker should be removed from the customer record.
- PWD stickers can only be issued for a motor vehicle. Customers can have a PWD plate for any trailer product.



Business Requirements

Code of Iowa/Administrative Rules/ARTS Functions

- PWD stickers do not have reciprocity with other states.
 - 23CFR Part 1235 Uniform System for Parking for Persons with Disabilities.
 - PWD placards and PWD plates are recognized by other states.
 - Interstate travel will require a PWD placard.
 - Customers can have both a PWD sticker and a PWD placard.
- Parking privileges associated with the sticker are not transferable. Unless
 the customer issued the sticker is the driver or passenger in the vehicle, it
 cannot be parked in a PWD space.
- Others can use the vehicle but cannot use PWD spaces unless they use a placard issued to them.
- Stickers cannot be issued to a parent who has a child with disabilities.



PWD Sticker Basics

- Issuing PWD stickers is modeled after the issuance of PWD placards.
- Issuance of PWD products requires an application.
- Issued to a customer with a permanent disability.
 - If a standard placard has been issued, customer only needs the application completed with qualifying plate information.
 - If no placard, need to present application and medical documentation.
- Only one sticker can be issued for a plate. The sticker must ONLY be displayed on the rear plate in the lower, right-hand corner.
- Reviewing vehicle information to ensure that there is a current registration is extremely important.



PWD Sticker Basics

- Anyone issued a sticker also needs a standard placard.
 - If the vehicle isn't available, the customer can use the standard placard with a different vehicle.
- If a customer is eligible for a PWD sticker, they can have a sticker for all the motor vehicles they own. If they own 3 vehicles, they can have 3 stickers.
 - This can be done in one transaction.
- Sticker numbers and placard numbers will not be the same.



Inventory

- PWD stickers are issued in rolls of 100.
- Ordered through the DOT MVD Online Ordering site.
- These stickers need to be added to the PWD inventory in ARTS.
- Stickers must be issued in numeric order.
- Counties should only order what is needed to support their daily workflow.



County Access

- To issue PWD stickers, a role needs to be added to the staff person's profile in ARTS.
- MVD is asking county leadership to identify 2 3 staff in their office that will be given access for issuing PWD stickers.
 - The request must be submitted through the "ARTS System Access Wizard".
 - ARTS > Tools > System Access Request > ARTS Access Request
 - The requested change is for PWD Sticker Issuance
- MVD wants to expand on the initial training and for counties to adopt their own office protocol.
- This supports a train-the-trainee model for the county to successfully and effectively build capacity.



Transactions

- Verify inventory
- Customer has no placards or a sticker.
 - Issue a placard and sticker.
- Customer has a sticker and no placard.
 - Issue a placard.
- Customer has a placard and no sticker.
 - Issue a sticker.
