January updates on vehicle program, policy, and process issues.

## **ERT**

Please note that we have posted tables showing ERT deals by county for 2020, 2021 and 2022 to <a href="https://iowadot.gov/mvd/factsandstats">https://iowadot.gov/mvd/factsandstats</a>.

In 2022, there were 38,825 deals completed in ERT which is a 36% increase compared to 2021.

### **ERT Used Car Enters Pilot Phase**

Following a successful round of testing, we have deployed the ERT Used Car programming into production as of January 26, 2023, for a pilot phase. During this pilot, expected to last about 2-3 months, we have nine dealers that will use ERT for used car deals. We will monitor the system to identify any errors or concerns, and then determine how and when to move to a full deployment. We have already been working with the counties where these pilot dealers are located, but the dealers may still send deals to any county based on the customer's residence.

Five dealers that could submit used vehicle deals as early as Thursday (1/26):

This form was updated this week. Among other improvements to make the form more user-friendly, the update adds language to the form whereby the title is required when applicable. We understand there are limited situations where a county may process the application without the title.

#### Annual vehicle data available on Web

## Code Move Notifications

## 7751/7757/7840/7861/7884 - ERT Used Car:

The first phase of ERT Used Car will be implemented with the code move. Since used card is more complex, it will be implemented in phases and not all transactions will be allowed with this phase. There are 9 dealers set up to pilot and additional training and information will follow. Congratulations and thank you to all that were involved in getting this launched. This is a huge step forward for ERT.

#### 7892 - Corrected Title:

This fix is under VRT 2 Title & Reg 2 Corrected Title; when the vehicle was correctly listed as 'Business Trade' the validation process would flip it back to 'Regular' and would fire the DE – Vehicle list price cannot be blank. This code fixes the Corrected Title functionality by using the current/correct Vehicle Usage.
