## June 2025

### New IL Title Brand

Illinois is introducing a new branding for vehicle titles to address the issue of wholesale and odometer rollbacks that they are currently experiencing. These IL titles will be branded with "odometer tampering," ensuring that future buyers are alerted, as the previous designation of "not actual miles" was often overlooked. The Illinois Secretary of State has confirmed that no changes to legislation or administrative rules are required to implement this new branding. An example of how the brand will appear on the title is provided below. Iowa will not carry forward the words "Odometer Tampering", but the title will still be Not Actual Mileage.
